Excerpts from the Bylaws
of the Arden Arcade Community Alliance

● **Article IV(A) MEMBERSHIP**

- 1) Membership in the Alliance shall be according to the following classifications:
 - a) **Member.** Any person, who is 18 years of age or older, and who shares the purposes stated in Article II above, shall be eligible to be a member of the Alliance if s/he is:
 - 1) a resident of Arden Arcade, or
 - 2) the single delegate designated as an official representative of:
 - (i) any legal business with a business address in Arden Arcade,
 - (ii) any nonprofit organization (such as churches, service clubs, welfare and labor groups) that operates in Arden Arcade, or
 - (iii) any public agency (such as schools, Park Districts, the Sheriff's Department, and Department of Human Assistance) that provide services in Arden Arcade.
 - b) **Associate Member.** Any person who is not eligible to be a Member (e.g. youth and persons from nonprofit organizations and public agencies that may desire membership for more than the single designated delegate) and whose objectives include the purposes stated in Article II above shall be eligible to be an Associate Member of the Alliance.

● **Article IV (C) "DUES"**

- 1) Each Member shall pay annual Dues of \$15 per calendar year, or such other amount as may be approved by the Members at an annual meeting of the Membership. [Note: Dues are currently \$15 per calendar year.]
- 2) Annual Dues shall be due and payable at or before the February Regular Meeting of the Membership.
- 3) Associate Members shall not be required to pay dues but shall be required to pay a fee established by the Executive Board for reproduction, mailing and other costs of providing documents requested by the Associate Member.
